General Information: My office is located in metro Atlanta, on the premises at Jean Padberg & Associates at 3136 Clairmont Road, NE, at the corner of Clairmont and Wilmont. It is 6/10 of a mile from I-85, between I-85 North and Buford Highway, just down and across the street from the Extended Stay Motel.

Free parking is available at the office and, for my clients who have a handicapped placard or license plate, there is a handicapped parking space across from the front door of the office.

Please note that I am not practicing law with Jean Padberg or any other attorney.

FROM DOWNTOWN ATLANTA: Take I-85 North to the Clairmont Road Exit. This is the next exit past North Druid Hills. The exit ramp is to the right. At the bottom of the exit ramp, take a left onto Clairmont Road and go underneath the interstate. There is a light just on the other side of the interstate and another light at the McDonald's, which will be on your right. Go through both lights. You will cross over a small bridge. The next light is Century Blvd. The next light is at the Extended Stay Motel. Just past this stoplight, my office is at the next street on the left, Wilmont. Turn left onto Wilmont and immediately turn left into the office parking lot.

FROM MARIETTA: Take I-75 South towards Atlanta, inside the perimeter, until you reach I-85 North. Take I-85 North to the Clairmont Road Exit. This is the next exit past North Druid Hills. The exit ramp is to the right. At the bottom of the exit ramp, take a left onto Clairmont Road and go underneath the interstate. There is a light just on the other side of the interstate and another light at the McDonald's, which will be on your right. Go past McDonald's, over a small bridge, and through the light at Century Center. The next light is at the Extended Stay Motel. Just past this stoplight, my office is at the next street on the left, Wilmont. Turn left onto Wilmont and immediately turn left into the office parking lot.

FROM DECATUR: Take Clairmont Road from Decatur and cross under I-85. There is a light just on the other side of the interstate and another light at the McDonald's, which will be on your right. Go past McDonald's, over a small bridge, and through the light at Century Center. The next light is at the Extended Stay Motel. Just past this stoplight, my office is at the next street on the left, Wilmont. Turn left onto Wilmont and immediately turn left into the office parking lot.

FROM GWINNETT COUNTY/NORTH I-85: Take I-85 South past Spaghetti Junction, to the Clairmont Road Exit. Take a right onto Clairmont. Go past McDonald's, over a small bridge and through the light at Century Center. The next light is at the Extended Stay Motel. Just past this stoplight, my office is at the next street on the left, Wilmont. Turn left onto Wilmont and immediately turn left into the office parking lot.

FROM ROSWELL/ALPHARETTA USING Georgia 400: Take 400 South to the Sidney Marcus Exit. Exit to the right and take a left turn at the end of the exit ramp onto Sidney Marcus. Sidney Marcus dead-ends into Buford Highway. Take a left onto Buford Highway, and immediately get into the right lane. The next light is Cheshire Bridge Road. Take a right onto Cheshire Bridge Road and immediately get into the left lane. Go underneath the interstate and make a left turn to access I-85 North.

Take I-85 North to the Clairmont Road Exit. This is the next exit past North Druid Hills. The exit ramp is to the right. At the bottom of the exit ramp, take a left onto Clairmont Road and go underneath the interstate. There is a light just on the other side of the interstate and another light at the McDonald's, which will be on your right. Go through both lights. You will cross over a small bridge. The next light is Century Blvd. Go through this light. The next light is at the Extended Stay Motel. Just past this stoplight, my office is at the next street on the left, Wilmont. Turn left onto Wilmont and immediately turn left into the office parking lot.

FROM ROSWELL/ALPHARETTA USING I-285 EAST: Take I-85 East to Spaghetti Junction. Take I-85 South past Spaghetti Junction, to the Clairmont Road Exit. Take a right onto Clairmont. Go past McDonald's, over a small bridge, and through the light at Century Center.

The next light is at the Extended Stay Motel. Just past this stoplight, my office is at the next street on the left, Wilmont. Turn left onto Wilmont and immediately turn left into the office parking lot.

FROM I-285 WEST - STONE MOUNTAIN/HWY 78: Take I-285 West/North to Spaghetti Junction. Take the I-85 South exit off I-285, towards Atlanta. Take I-85 South to the Clairmont Road Exit. Take a right onto Clairmont. Go past McDonald's, over a small bridge, and through the light at Century Center. The next light is at the Extended Stay Motel. Just past this stoplight, my office is at the next street on the left, Wilmont. Turn left onto Wilmont and immediately turn left into the office parking lot.
